5 CLAIMS.

- 1) An improved laser marking & engraving machine consisting of the laser head comprising of head, mirror mount to mount the mirror, Q-switch to mount the Q-switch, Aperture mount to regulate the aperture so as to vary the intensity of the Laser Beam, which is further provided with a beam bender for positioning the beam in a required direction which is supported in a rail & connected to a control panel provided with power supply, RF Driver, Heat Exchanger, Chiller to generate a laser beam of required intensity for marking/etching, engraving, scrubbing, cutting as per the required design programmable through a computer on metals and non-metals through beam steered galvo's and flat field galvo's/scanning heads.
