
Dear Sir,


Re: Violation of the Patent No. 188787 & 189027

It may not be out of place here to inform you that the aforesaid Patent is still valid and subsisting in my favour as the order passed by the Intellectual Property Appellate Tribunal is being stayed by the Hon'ble High Court of Judicature at Madras in Writ Petition No. 18565 & 18566.

I once again have called upon you in the interest of your members, to desist them self from committing any violation of my aforesaid Patent, failing which PLEASE NOTE that I shall be constrained to move the appropriate Court of Law for enforcing my rights against the members who have willfully infringed my patent rights.
