IPAB order dated 12/06/2012 was challenged by Mr.Bharat Bhogilal Patel by writ petition Number 18565 and

18566 of 2012 at Honourable Madras High Court, in which the Honourable Madras High Court vide order dated 19/11/2012 had granted Interim stay for six weeks on the order of IPAB regarding revocation of the patents.
