I am directed to refer to your RTI application dated 18.09.2012 addressed to CPIO, Department of commerce which was transferred by them and received in this Department on 27.09.2012 and to furnish the point wise information to you as under :-

(a) Prime Minister's Office forwarded vide their PMO/ID.No.14/3/2011-PMP2/260819 dated 18.02.2011 to this Department, your representation dated 31.01.2011 for action as appropriate, which was received in this Department on 03.03.2011. In your aforesaid representation, you had raised the issue of enforcement of your two Patents and requested to resolve the problems of infringement of your patents by various manufacturers/importers. You had also sought certain clarifications regarding enforcement and infringement.


It may be stated in this regard that your similar representation dated 07.02.2011 addressed to the Commerce Secretary was received in this Department in 11.02.2011 and this Department, vide letter dated 05.04.2011 replied in respect of the clarifications sought by you. In addition, this Department, in response to your earlier representation dated 09.09.2010 addressed to Minister of HI&PE, had already intimated to you that Patents Rights may be enforced as per provisions of the Patents Act through Suits for enforcements/relief.
